Action Ministries provided food, paper products and groceries to families 9,199 times during 2020. We helped 2,485 different households and 767 families per month. In addition to food purchased by Action Ministries, food and other household products were donated by businesses, schools and individuals. In addition to the families of Northern Kentucky we served on a monthly basis, Action Ministries provided food and paper products to Food Pantries, Churches, Schools and families in Ohio, Kentucky and Indiana. Over 1,358,987 pounds of food were distributed in 2020.
